Notes from meeting of 18th November

Finance: the current account stands at £1146.73. Income had been received from the Community Fayre and September membership fees.

Reports: were received from the Town Council by their appointed representative Councillor Alan Mackender Lawrence, information received from Neighbourhood Watch and progress on plans for a Village Fayre in the summer.

Planning Applications: four applications were discussed. Only one was new not requiring comment, two related to tree work and the fourth was a permission.

Notes from Meeting of 13th January

Finance: the balance now stands at £834.73 as £288 has been paid out for the History Board. It was noted that the bond matures on July 7th. The current rate of interest is 1.4% and it was agreed that the bond should be renewed.

Planning: it was noted that an appeal has been made to the Inspector for the application for two flats in Main Street by the King of the Belgians which was previously turned down by the District Council. The application for erection of the History Board has been approved.

Website: it was decided that the Hartford Conservation Group should develop a website. A local neighbour has offered to develop this and Mike Humphrey will liaise with him.

The Horse Chestnut Tree, Main Street, Hartford



This is the tree as shown in the newsletter of May 2013 when concern was expressed that the tree was dying.



These are the remains of the Horse Chestnut tree in Main Street, Hartford. The tree fell across the road in a storm on February 2nd 2014. Local residents joined together to cut the tree back sufficiently to clear the road for immediate access and Huntingdonshire District Council Arboricultural Department removed the remains.

And this is the remaining tree which has undergone some crown reduction. It is hoped that it will develop well in the coming spring.

These two trees were a landmark at the entrance to the village of Hartford and it is hoped that the remaining tree will survive for years to come.
